# What is the Certificate in Paraplanning?

The Level 4 Certificate in Paraplanning was developed in conjunction with Paraplanners, Financial Planners and trainers to test the application of skills and the technical knowledge needed by Paraplanners.

If you are currently working as a Paraplanner, whether in-house or outsourced, the qualification will help you by building on your existing skills and enable you to become more efficient in your job. If you are thinking of becoming a Financial Planner in the future, then this is an ideal step towards CFP<sup>™</sup> certification as it covers some of the core competences tested as part of this globally recognised qualification.

# Who should study the qualification?

The Certificate in Paraplanning is the ideal qualification for individuals who are currently practising as a Paraplanner in the UK.

It's a challenging and relevant qualification which is designed to further develop and test your financial planning skills and how well you can apply technical knowledge in Financial Planning situations. Success in the exam also provides powerful professional recognition that you have the appropriate combination of technical knowledge and planning skills required to fulfill the role of Paraplanner.

## Studying for the Certificate in Paraplanning

#### **Financial Planning & Advice**

This multiple choice question (MCQ) exam is computer based, consists of 80 questions and lasts 2 hours. We recommend a minimum of 140 hours study and upon successful completion you will be awarded 10 CPD hours.

Syllabus covers: **Financial Protection** - Consumer and Retail Market Factors and Trends Relevant to Financial Protection • Protection Planning and Solutions • **Retirement Planning** - Pension Provision in the Context of Political, Economic, Legal and Social Environment Factors • Pension Scheme Taxation, Law and Regulation • Defined Benefit (DB) and Defined Contribution (DC) Schemes • Financial Planning and Advice for Retirement • **Financial Planning** • Financial Planning Fundamentals and Assumptions • Establishing the Client - Planner Relationship • Client's Information Collection and Analysis • Developing, Communicating, Implementing and Reviewing Financial Planning Recommendations

#### **Investment Risk & Taxation**

This multiple choice question (MCQ) exam is computer based, consists of 80 questions and lasts 2 Hours. We recommend a minimum of 140 hours study and upon successful completion you will be awarded 8 CPD hours.

Syllabus covers: Asset Classes · The Macro-Economic Environment · Principles of Investment Risk and Return · Taxation of Investors and Investments · Investment Products · Portfolio Construction and Planning · Investment Advice · Portfolio Performance and Review


